MOTION TO CONSOLIDATE DOCKETS

On October 5, 2007, Yarnell Water Improvement Association, Inc., ("Yarnell" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for a permanent increase in rates and charges.

On March 3, 2008, Commission Utilities Division Staff ("Staff") issued a Notice of Sufficiency and classified Yarnell as a Class C utility.

On March 19, 2008, pursuant to A.A.C. R-14-3-101, Commission Hearing Division issued a procedural order setting a hearing in this matter for July 22, 2008.

On July 7, 2008, the Hearing Division issued a procedural order directing Yarnell to file a separate financing application, and on July 14, 2008, Yarnell filed its financing application in Docket No. W-02255A-08-0355.

On July 22, 2008, the Hearing Division directed Staff to file a motion to consolidate the two matters. A single hearing on the two matters would reduce the demand on Commission resources.

WHEREFORE, Staff hereby respectfully requests that the instant rate application be consolidated with Docket No. W-02255A-08-0355.
