PROCEDURAL ORDER

BY THE COMMISSION:

On July 14, 2008, Joseph T. LaMarca filed with the Arizona Corporation Commission ("Commission") a Formal Complaint against Arizona Public Service Company ("APS") alleging that APS had failed to comply with Commission regulatory requirements and with APS's documented commitments when it cut off power to Mr. LaMarca's Prescott home on June 12, 2007. According to the Complaint, APS cut off the power because Mr. LaMarca had mistakenly paid only a portion of APS's bill on May 26, 2007, leaving a balance due of \$38.37. The Complaint also states that, although the balance due was paid in full on June 17, 2007, APS failed to restore power until June 29, 2007.

On July 28, 2008, Mr. LaMarca filed a letter stating that, through the efforts of Ms. Jennie Vega of APS, the issues within the Complaint had been mutually resolved. Mr. LaMarca also stated that he was withdrawing the Complaint and indicated that the matter should be closed.

APS has not made any filings in this docket.

In light of Mr. LaMarca's desire to withdraw the Complaint and have the matter be closed, it is appropriate to close this docket.
