Pursuant to Rule XII(c)(2)(B), Uniform Rules of Practice, Christopher T. Rapp and Ashley Adams of Ryan Rapp & Underwood, P.L.C. hereby moves the Administrative Law Judge to allow Ryan Rapp & Underwood to withdraw from further representation of Respondents Ryan Herndon and Trend Capital, LLC, in the above-referenced action. This motion is made because defendant was sentenced to serve a prison term of three and a half (3 ½) years and is currently in custody in Globe, Arizona, at an Arizona State facility prison, and will be unable to obtain employment. Defendant currently owes Ryan Rapp & Underwood, P.L.C. a total of \$25,675.59 in attorneys' fees for various matters, including this one, and will likely be unable to pay such fees for many years to come, if at all. There are numerous pleadings associated with this matter, and in the corresponding Receivership pending in civil court, which are burdensome upon counsel to continue to have to review, without further payment from Mr. Herndon.
