PROCEDURAL ORDER

BY THE COMMISSION:

On October 18, 2007, the Arizona Corporation Commission ("Commission") Utilities Division Staff ("Staff") filed a request by memorandum that a docket be opened in the above-captioned matter. Additionally, Staff also filed a copy of its memorandum concerning its field and office visits to Litchfield Park Service Company ("LPSCO") on July 10, 2007, from Docket No. SW-01428A-06-0444.

On August 8, 2008, by Procedural order, since nothing further had been filed in this docket, Staff was directed to file an update by August 15, 2008, to determine whether the docket should remain open or be closed administratively.

On August 14, 2008, Staff filed a memorandum indicating a recent visit had been made to LPSCO's treatment plant and described on-going plant upgrades. Staff recommends that the docket remain open until wastewater treatment plant construction upgrades have been completed and the necessary regulatory approvals have been issued.

IT IS THEREFORE ORDERED that this docket shall remain open until the construction upgrades have been completed and approved after which Staff shall file a further update.
