BY THE COMMISSION:

On April 17, 2008, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Deborah Cheryl Bennett and A. James Bennett, M.D. (collectively, the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of unregistered investment opportunities involving "channel trading."

The Respondents were duly served with a copy of the Notice.

On April 21, 2008, Respondents filed a request for hearing.

Pursuant to a Procedural Order dated May 9, 2008, a Pre-Hearing Conference was held on June 30, 2008, during which the parties requested that a Status Conference be scheduled.

Pursuant to a Procedural Order dated June 30, 2008, a Status Conference was held on August 19, 2008. The parties stated that they are working toward a settlement in the matter and requested that a status conference be set.

Accordingly, a Status Conference should be scheduled.

IT IS THEREFORE ORDERED that a **Pre-Hearing Conference** to determine the status of this matter shall commence on **October 8, 2008, at 9:00 a.m.**, or as soon thereafter as is practical, at the Commission's offices, Room 218, 400 West Congress, Tucson, Arizona, 85701. **The parties**


