PROCEDURAL ORDER

**BY THE COMMISSION:**

On May 23, 2007, Picacho Peak Water Company, Inc. ("Picacho" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for authority to incur debt to finance water system improvements under Docket No. W-02351A-07-0319.

On December 13, 2007, Picacho filed with the Commission an application for a rate increase under Docket No. W-02351A-07-0686.

Pursuant to a Procedural Order issued February 11, 2008, Docket Nos. W-02351A-07-0319 and W-02351A-07-0686 were consolidated.

On March 20, 2008, the Commission's Utilities Division Staff ("Staff") notified Picacho that its applications were sufficient as of February 28, 2008. Staff is required pursuant to Arizona Administrative Code R14-2-103(B)(11)(B) to file its Staff Report within 75 days of a sufficiency finding—in this case, no later than May 15, 2008.

On May 13, 2008, Staff filed its Request for an Extension of Time to file its Staff report from May 15, 2008 to May 21, 2008.

Staff's request was granted pursuant to a Procedural Order dated May 19, 2008.

Staff filed its Staff Report May 21, 2008.

On May 30, 2008, the Company filed its Request for an Extension of Time to File Comments to Staff Report from June 2, 2008 to June 9, 2008. Staff did not object to the Company's extension

1 request.

2 The Company's request was granted pursuant to a Procedural Order dated June 5, 2008.

3 On June 9, 2008, the Company filed its Comments on Staff Report ("Comments"). In its  
4 Comments, the Company proposed an alternate rate structure, among other things.

5 On August 8, 2008, Staff filed its Responsive Staff Report to the Company's Comments.

6 On August 18, 2008, the Company filed its Request for an Extension of Time to File  
7 Comments to [Responsive] Staff Report. Staff does not object to the Company's request.

8 On August 29, 2008, a Procedural Order was issued requiring the Company to mail notice of  
9 Staff's recommended rates and notice of its financing application by August 25, 2008. The time clock  
10 was extended for 30 days to give the Company time to comply.

11 Accordingly, the Company's request for an extension of time to file its comments to Staff's  
12 Responsive Staff Report should be granted.

13 IT IS THEREFORE ORDERED that the Company's extension request is granted. The  
14 Company shall file its comments to the Responsive Staff Report on or before **4:00 p.m., August 27,**  
15 **2008.**


