

PROCEDURAL ORDER

BY THE COMMISSION:

On March 25, 2008, Ridgeline Water Company L.L.C. ("RWC" or "Company") filed with the Arizona Corporation Commission ("Commission") an Application for a Certificate of Convenience and Necessity ("CCN" or "Certificate") to provide water service in Pima County, Arizona.

On April 16, 2008, the Commission's Utilities Division Staff ("Staff") notified the Company that its application was not sufficient pursuant to the Arizona Administrative Code.

On April 23, 2008, RWC responded to Staff's Insufficiency Letter.

On May 5, 2008, Staff filed a second Insufficiency Letter.

On May 27, 2008, RWC responded to Staff's second Insufficiency Letter.

On June 6, 2008, Staff notified the Company that its Application is sufficient pursuant to the Arizona Administrative Code.

On June 30, 2008, a Procedural Order was issued setting a hearing in this docket for September 4, 2008, at the Commission's Tucson offices.

On August 21, 2008, during a conference call among the parties and the Administrative Law Judge, the parties indicated that they wished to reset the scheduled hearing date in order that the parties may address certain questions raised by Staff in the Staff Report.

1 IT IS THEREFORE ORDERED that the **hearing** on this matter shall be **reset to October 2,**
2 **2008, at 10:00 a.m.** or as soon thereafter as is practical, at the Commission's offices, **Room 222, 400**
3 **West Congress Street, Tucson, Arizona 85701.**

4 IT IS FURTHER ORDERED that the **hearing presently scheduled on September 4, 2008,**
5 **at 10:00 a.m., shall convene at the Commission's Offices, Room 222, 400 West Congress Street,**
6 **Tucson, Arizona 85701, for purposes of taking public comment only.**

7 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules
8 of the Arizona Supreme Court and A.R.S. §40-243 with respect to the practice of law and admission
9 *pro hac vice.*

10 IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance
11 with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Rule 42 of the
12 Rules of Arizona Supreme Court). Representation before the Commission includes appearing at all
13 hearings and procedural conferences, as well as all Open Meetings for which the matter is scheduled
14 for discussion, unless counsel has previously been granted permission to withdraw by the
15 Administrative Law Judge or the Commission.

16 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized
17 Communications) applies to this proceeding and shall remain in effect until the Commission's
18 Decision in this matter is final and non-appealable.

19 IT IS FURTHER ORDERED that the time clock for issuing a Decision in this matter is
20 extended for 28 days, until December 12, 2008.


