PROCEDURAL ORDER

BY THE COMMISSION:

On August 31, 2007, Southwest Gas Corporation filed with the Arizona Corporation Commission an application for a rate increase.

A hearing was held in June 2008, and, at the conclusion of the hearing, a briefing schedule was established with initial briefs and reply briefs due by August 8 and 22, 2008, respectively.

On August 21, 2008, Staff filed an Unopposed Request for Extension of Time to File Reply Briefs. Staff seeks an extension until August 25, 2008 to file reply briefs and represents that no party opposes the request.

IT IS THEREFORE ORDERED that Staff's Unopposed Request for Extension of Time to File Reply Briefs is hereby granted. Reply briefs shall be filed by no later than August 25, 2008.

IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


