

Dear Commissioners:

Responding to Commissioner Mayes request for information, Mohave Electric notifies you that a mining operation exploded dynamite last week near a Mohave substation furnishing electricity to a portion of the Mohave system and also to the line servicing the Hualapai and Havasupai tribal areas, blasting debris into the Mohave substation and causing an outage for the system that required about 2 hours to restore service.

Otherwise, the electric system serving the northern area of the Mohave Certificated service area and the 70 mile line to the Hualapai and Havasupai tribes continues to provide reliable electric service under the Mutual Aid Agreement among APS, UniSource and Mohave Electric. As outages have occurred periodically, after receipt of notice they are restored pursuant to the Agreement.
