PROCEDURAL ORDER

BY THE COMMISSION:

On July 10, 2008, Time Warner Cable Information Services (Arizona) ("TWCIS" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for approval of an internal restructuring that will result in a *pro forma* change of control.

On August 15, 2008, the Commission's Utilities Division Staff ("Staff") filed a memorandum recommending administrative closure of this docket ("Memorandum").

In its Memorandum, Staff noted that TWCIS' annual revenues are less than \$1 million. Pursuant to Arizona Administrative Code ("A.A.C.") R14-2-802, the Affiliated Interest Rules (A.A.C. R14-801 - 806), apply solely to Class A companies. Because TWCIS' revenues are less than \$1 million, Staff has classified the Company as a Class B entity. As such, Commission approval of the Company's *pro forma* restructuring is not required.

Given the foregoing, Staff concluded that the Company's application should be deemed solely informational and no further action on this docket is required. Staff therefore recommends that this matter be administratively closed.

Accordingly, the above-referenced docket shall be administratively closed.




