11 **STAFF'S MOTION TO CONSOLIDATE**

12 On May 27, 2008, the Beaver Dam Water Company, Inc. ("Beaver Dam" or "Company")
 13 filed an application for emergency (debt) authorization in support of a loan with the WIFA funding
 14 agency in the amount of \$104,283 for the purpose of constructing water storage improvements
 15 (Docket No. W-03067A-08-0266). On September 3, 2008, the Staff the Utilities Division ("Staff")
 16 sent out its first set of data requests to Beaver Dam, with a response due within ten days of its receipt.

17 On July 23, 2008, Beaver Dam filed an application for a rate increase (Docket No. W-
 18 03067A-08-0380). On August 22, 2008, Staff issued a letter of deficiency. Pursuant to the letter, the
 19 Company has until September 6, 2008, to correct the deficiencies or make other arrangements with
 20 Staff to remedy the rate application.

21 Pursuant to R14-3-109(H), Staff respectfully requests that Dockets W-03067A-08-0266 and
 22 W-03067A-08-0380 be consolidated. Staff believes that consolidation is appropriate, since these two
 23 dockets are intricately related. Any long-term debt which the Company acquires will need to be
 24 reflected in the Company's capital structure for rate case purposes. Staff has talked to the Company
 25 about consolidation of the two dockets, the Company has no objection, and no party's rights would
 26 be prejudiced.
