AFFIDAVIT IN SUPPORT OF SERVICE BY PUBLICATION RE:

STANLEY LANE BOBLETT (a/k/a Lane Boblett)

I, Michael Rice, Special Investigator for the Arizona Corporation Commission, Securities Division, swear and affirm that the following attempts have been made to contact Respondent Stanley Lane Boblett (Respondent):

A notice by certified mail was issued and sent to Stanley Lane Boblett at 468 N. Camden Dr., Suite 200, Beverly Hills, CA 90210, 38211 N. Sombrero Rd., Scottsdale, AZ 85377, and P.O. Box 346, Cave Creek, AZ 85327. The notices were returned by the United States Postal Service unclaimed. The above Respondent had not expressly authorized the mail destination service to accept certified mail on their behalf.

A diligent search and inquiry for the Respondent was conducted in the following manner:

1. A check of the United States Post Office for the current address revealed that mail is being delivered to P.O. Box 346, Cave Creek, AZ 85327. There is no forwarding address.
2. There are no known Arizona regulatory agency listings, including professional or occupational licensing, for the Respondent.
3. A check of all telephone listings in the last known location of the Respondent yielded negative results.
4. A check with each landlord or leasing agent within the State of Arizona having contact with or contractual relationship with the Respondent revealed the following: Susan Shafer rented 7272 E. Gainey Ranch Rd. Scottsdale, AZ 85258 to Stanley Lane Boblett from October 2006 until January 2008, when he was evicted for non-payment of rent. He gave no forwarding address; Simeone White rented 38127 N. Boulder View, Scottsdale, AZ 85262 to Stanley Lane Boblett from February 2005 until March 2007. Stanley Lane Boblett moved out of the house by April 1, 2007 when it was sold. He gave no forwarding address; and Julie Park rented 38211 N. Sombrero Rd., Scottsdale, AZ 85377 to Stanley Lane Boblett from May 2008 until July 2008 when he was evicted and left no forwarding address, although he did tell Ms. Park that he was moving to the "East Coast."
5. A check of all telephone service providers, including wireless or cellular service, for the Respondent revealed a cellular number of 310-497-9185 but no new addresses. Numerous attempts were made to call this phone number from August 5, 2008 until September 2, 2008. Two voicemail messages were left and other attempts to leave messages were unsuccessful due to the mailbox being full. On August 25, 2008, I received a voice mail message from a person identifying himself as Lane Boblett, but no other contact has been made.

6. A check of the Maricopa County Assessor's Office for the Respondent yielded negative results.
7. A check of the Maricopa County Recorder's Office for the Respondent yielded negative results.
8. A check of the Maricopa County Superior Court for the Respondent yielded the following cases involving the Respondent: CV2007-090985 Kevin & Carol Heher vs. Lane Boblett & Pacific Coast Holdings, Inc.; CV2007-070128 Jeremy Morganegg vs. Pacific Coast Holdings, Inc.; CC2007-249129 Susan Schafer vs. Lane Boblett; CC2007-051461 Jaguar North Scottsdale vs. Lane Boblett & Pacific Coast Holdings; CC2006-062363 Eric Salberg vs. Lane Boblett; 0711CV-0104316 Sonya Pax vs. Lane Boblett; and JC2007-126947 State of Arizona vs. Stanley Lane Boblett. No new addresses were revealed.
9. A check of all mail service companies including UPS, Federal Express, etc, for the Respondent yielded negative results.
10. A check of all Internet providers and email service providers known to have been used by the Respondent provides no new addresses.
11. A check of all banks and financial institutions that had or may have had a contractual relationship with the Respondent listed no new addresses.
12. There are no known vendors that supplied business services or resources for the Respondent.
13. A computer and Internet search for the Respondent yielded negative results.
