BY THE COMMISSION:

On April 17, 2008, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Deborah Cheryl Bennett and A. James Bennett, M.D. (collectively, the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of unregistered investment opportunities involving "channel trading."

The Respondents were duly served with a copy of the Notice.

On April 21, 2008, Respondents filed a request for hearing.

Pursuant to a Procedural Order dated August 9, 2008, a Status Conference was held on October 8, 2008. The parties stated that they are working toward a settlement in the matter and requested that a status conference be set.

Accordingly, a Status Conference should be scheduled.
