Dear Ms. Kilger:

The subject Decision required, among other things, that the Company file a lost water status report by September 5, 2008. The losses that were at issue in the subject case were addressed by the Company's Financing Application in Docket Nos. W-02121A-07-0506 & W-02121A-07-0688, resulting in Decision No. 70308. That Decision provided the resolution of the water loss problem by authorizing WIFA financing in the amount of \$124,000 for the Water Meter Replacement Program therein described including the purchase and installation of approximately 300 new meters to replace very old meters that were the cause of the losses. The Company was allowed one year from that Decision, or until April 24, 2009, to install the meters, and is to provide an annual report on losses by April 24, 2010.


As of this date, approximately 85 meters have been installed, and the Company is of the opinion that the major source of losses has been, or is nearly, corrected. The April 24, 2010 Report should confirm that opinion.

We provide this letter as the final compliance requirement for Decision No. 68751. The Company is of the belief that this filing completes all requirements under Decision No. 68751. If the Staff does not concur with that belief, we would appreciate being so advised at your earliest convenience.
