PROCEDURAL ORDER TO
CORRECT TYPOGRAPHICAL ERROR

BY THE COMMISSION:

In Decision No. 70482 (September 3, 2008), the Arizona Corporation Commission ("Commission") approved a rate increase request by Bellemont Water Company ("Company"). The Company was ordered to file on or before September 1, 2008, with the Commission's Docket Control, revised rate schedules for approved rates and charges. It has come to the Commission's attention that the Decision contains a clerical typographical error in the ordering paragraph on page 8. Although Findings of Fact No. 8 on page 3 of the Decision correctly sets forth the rates and charges, the ordering paragraph on page 8 incorrectly shows a Nonresidential Commodity Charge of "0 to 4,000 gallons," instead of "0 to 10,000 gallons." Accordingly, the Decision should be corrected *Nunc Pro Tunc* to correct the clerical typographical error.

IT IS THEREFORE ORDERED that the clerical typographical error, "0 to 4,000 gallons," which appears in Decision No. 70482, at page 8, line 24, shall be corrected to read "0 to 10,000 gallons."

IT IS FURTHER ORDERED that all other Ordering paragraphs shall remain in effect.


