REQUEST FOR EXTENSION OF TIME

Applicant Del Rio Water Company (the "Company") requests that the hearing set for November 14, 2008, in this matter be delayed for at least thirty (30) days and that the related deadlines in the Procedural Order be extended accordingly. *The Company has discussed this request with Staff and Staff does not oppose it.*


The Procedural Order dated August 8, 2008, provides that the hearing in this matter shall reconvene on November 14, 2008. It further provides that a Supplemental Staff Report must be prepared by October 15 and the Company's responses thereto must be filed by October 31.

Pursuant to the Procedural Order, Staff has made additional data requests to the Company. Staff has informed the Company that it needs complete answers to data requests by September 15 in order to meet Staff's obligations under the Procedural Order.

1 The Company's sole member, The Bond Ranch at Del Rio Springs, LLC, is in the middle
2 of a refinancing which will not be completed by September 15. The Company therefore cannot
3 timely comply with Staff's data requests, some of which relate to finances. Extension of the
4 hearing date and related deadlines by thirty (30) days will give time for the necessary preparation
5 for the reconvened hearing.

6 The Company therefore respectfully requests that the hearing be vacated and rescheduled
7 for December 15, 2008, or later, and that deadlines for preparation of the Supplemental Staff
8 Report and the Company's responses thereto be extended for at least thirty (30) days each.


