PROCEDURAL ORDER

BY THE COMMISSION:

On August 11, 2008, Arizona Public Service Company ("APS" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for the sale and transition of certain facilities in Pinal County pursuant to A.R.S. § 40-285(A) and for deletion from its Certificate of Convenience and Necessity ("CC&N") from certain areas of Pinal County.

On August 13, 2008, the Electrical District No. 3 of Pinal County ("ED3") filed a Motion to Intervene ("Motion") in the above-captioned matter.

No objections have been filed and accordingly, the Motion should be granted.

IT IS THEREFORE ORDERED that ED3 is hereby granted intervention.
