**REQUEST FOR PROCEDURAL

13 Chaparral City Water Company, Inc. ("the Company") hereby submits this Request
14 for a Procedural Conference in the above-referenced matter.

15 On September 8, 2008, the Company filed a Motion for Approval of Interim Rates,
16 with supporting testimony and schedules. As discussed in detail in the motion and
17 supporting testimonies, the Company needs the relief of interim rates to prevent the
18 continued erosion of the Company's financial condition, a condition that is worsening due
19 to the significant delays the Company has experienced in obtaining rate relief.

20 On September 11, 2008, counsel for the Company conferred with counsel for Staff
21 and RUCO and the parties agreed that responses to the Company's request would be filed
22 on or before September 23, 2008. The Company now requests that a Procedural
23 Conference be scheduled so additional procedural dates can be scheduled, including the
24 scheduling of a hearing at the earliest possible time.
