The Procedural Order specified a completion date of August 19th, so the final weekly publication of notice was in fact published one day later than that set out in the Procedural Order. However, upon conferring with Judge Stern prior to publication, it was determined that the August 6, 13 and 20th weekly publication dates, along with the daily publication in the Arizona Daily Star and Tucson Citizen, would satisfy the public notice requirements set out in the Procedural Order dated July 24, 2008.
