RE: STAFF'S RESPONSE TO LATE FILED EXHIBITS FILED BY MOUNT TIPTON WATER COMPANY, INC. FOR AN EMERGENCY RATE INCREASE (DOCKET NO. W-02105A-08-0262).

On May 23, 2008, Mount Tipton Water Company, Inc. ("Company") filed an application with the Arizona Corporation Commission requesting an emergency rate increase. On July 11, 2008, Staff filed its Staff Report pertaining to this filing.

Subsequent to Staff's filing of its Staff Report, the Hearing Division issued a procedural order dated August 26, 2008, requiring the Company to late file three additional exhibits by September 8, 2007. Additionally, Staff was instructed to review these exhibits and to file any comments it may have to these exhibits by September 16, 2008.

The Company was ordered to furnish a complete copy of the April 2008 letter from Pete Byers, documentation showing Mount Tipton's actual tax liability as to both of its parcels, and a balance sheet and income statement.

The Company filed the April 2008 letter from Pete Byers, documentation from Mohave County Treasurer showing the tax liability, and an income statement as late filed exhibits with Docket Control on September 10, 2008. The Company did not file the required balance sheet exhibit.

Staff reviewed the late filed exhibits. Based on Staff's review Staff's recommendations remains unchanged from its filed Staff Report of July 11, 2008.

Staff continues to recommend approval as filed in its Staff Report dated July 11, 2008.
