Global Water - Santa Cruz Water Company and Global Water - Palo Verde Utilities Company (collectively, "Global Utilities") respectfully request a minor technical amendment to the proposed order submitted by Staff. In particular, the ordering paragraphs (Pages 5 and 6) refer to "Global Water - Santa Cruz Water Company, LLC" and "Global Water - Palo Verde Utilities Company, LLC". However, the Global Utilities are not LLCs, they are corporations. See Decision No. 69920 (Sept. 27, 2007) at Finding of Fact No. 8. Accordingly, the letters "LLC" should be deleted from the ordering paragraphs. Proposed language for an amendment is included as Exhibit A.
