
**CROSS CREEK RANCH

 15 The Cross Creek Ranch Community Association (the "CCRHOA") hereby files  
 16 this Motion to Consolidate the above-captioned matter with the Application for Transfer  
 17 of Assets via Dissolution, and Cancellation of Certificate of Convenience and Necessity  
 18 filed by the Cross Creek Ranch Water Company ("Water Company"), Docket Nos. W-  
 19 20619A-08-0471 and W-04131A-08-0471, filed on September 8, 2008. The Water  
 20 Company has filed an application for an approval of transfer of utility assets to CCRHOA,  
 21 which is essential before the Commission can grant the relief requested by the CCRHOA.  
 22 The Water Company also requests that, upon the transfer of assets, the Commission delete  
 23 its Certificate of Convenience and Necessity. Since these two matters are inextricably  
 24 linked, consolidation is consistent with the interests of administrative efficiency and  
 25 judicial economy.
