PROCEDURAL ORDER

BY THE COMMISSION:

On May 11, 2006, Verde West Irrigation ("Verde" or "Applicant") submitted to the Arizona Corporation Commission ("Commission") an application for the sale of assets and transfer of its Certificate of Convenience and Necessity ("Application").

On June 6, 2006, the Commission's Utilities Division Staff ("Staff") filed a Letter of Insufficiency and requested that the Applicant provide additional information related to the Application.

On September 22, 2006, Staff filed a second Insufficiency Letter. To date, Applicant has not responded to Staff's data requests.

On June 16, 2008, a Procedural Order was issued directing Staff to provide an update on the status of this matter.

On June 23, 2008, Verde filed a letter requesting that the docket be closed and stating that the Applicant is unable to resolve the issues with the Application at this time.


On September 3, 2008, Staff filed a Response to Verde's request stating that it is Staff's understanding that issues of ownership have arisen regarding the company, that the issues are not likely to be resolved in the immediate future, and that Staff does not object to the closing of this docket. According to Staff's Response, it is Staff's position that, despite the ownership issues, Verde is still a public service corporation and must continue to service its existing customers.
