STATUS REPORT AND REQUEST FOR ADDITIONAL STAY OF PROCEEDING

On April 8, 2008, Broadweave Networks of Arizona ("Broadweave") filed a Request for Temporary Stay of Proceeding in the above-captioned docket. On April 14, 2008, the Arizona Corporation Commission's Administrative Law Judge issued a Procedural Order granting the requested stay and ordering that Broadweave file a status report on or before October 10, 2008. This filing constitutes the status report required by the procedural order.

As a result of the current downturn in the Arizona real estate market, plans for many new master planned developments have been delayed or cancelled. This, in turn, has significantly reduced the opportunities to compete for new telecommunications customers. Thus, Broadweave requests an additional stay in this proceeding of one year, or until October 6, 2009. Broadweave has contacted Utilities Division Staff regarding this request, and Staff does not oppose the request. If the requested stay is granted, Broadweave will file another status report on or before October 6, 2009.
