**MOTION TO REVISE CUSTOMER
NOTICE**

1 Sunrise Water Co. ("Sunrise") hereby asks that the first paragraph of the public notice
2 language in the September 8, 2008, Procedural Order be revised to read as follows:

3 On August 1, 2008, Sunrise Water Company ("Sunrise" or "Company") filed an
4 application with the Arizona Corporation Commission ("Commission") for a
5 permanent base rate revenue increase of approximately \$285,932, or 22 percent over
6 current revenues. If the Company's proposal were to be adopted, a single-family
7 residential customer with a ¾ inch meter, and average monthly usage of 17,782
8 gallons, would experience a bill increase from ~~\$73.86~~ \$62.68 to ~~\$85.04~~ \$73.86 (17.84
9 percent). For a residential customer with a 1 inch meter, and average monthly usage
10 of 26,737 gallons, the monthly bill would increase from \$92.70 to \$111.41 (20.18
11 percent). The actual percentage rate change for individual customers would vary
12 depending upon the type and quantity of service provided.

13 The existing and proposed average bills for a ¾ inch customer of \$62.68 and \$73.86,
14 respectively, are the same amounts contained in Mr. Jones' direct testimony and in the H-4
15 Schedules. Mr. Jones has also discussed the proposed revision with Mr. Igwe of the Utilities
16 Division Staff, who agrees that the revisions should be made.


