26 The Town of Paradise Valley, an Arizona municipal corporation ("Town") respectfully
27 applies for leave to intervene in this proceeding under A.A.C. R14-3-105.

I. The Town should be granted intervention.

Persons who are "directly and substantially affected by the proceedings" may apply to
intervene. A.A.C. R14-3-105. The Town is a customer of Arizona-American, and the Town is
therefore directly and substantially affected by this rate case. Further, many of the Town's
residents are customers of Arizona-American and those customers will be directly affected by this
rate case. Moreover, the Town was granted intervention in the proceedings that resulted in
Decision No. 70488. (Decision No. 70488 at page 3, lines 8-9). Many of the rate issues addressed
in Decision No. 70488 will be re-examined in this case, and the Town has a continuing interest in
those issues.
