NOTICE OF INTENT TO BE A PARTY

I.

Pursuant to A.R.S. 40-360.05 (A), the ARIZONA UTILITY INVESTORS ASSOCIATION, INC. (AUIA) hereby files notice of its intent to be a party to the above-captioned proceeding.

II.

AUIA is a nonprofit domestic corporation which represents the interests of investors in electric, gas, water and telecommunications companies that are based in or are authorized to do business in the state of Arizona. As such, AUIA qualifies as a party to the certification proceeding as defined in A.R.S. 40-360.05 (A) (3).

AUIA's membership includes approximately seven thousand individuals, many of whom own the first mortgage bonds of Salt River Project (SRP).
