On September 18, 2008, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order ("T.O.") and Notice of Opportunity for Hearing ("Notice") against Jerome William Carter dba Good Only Done Productions, L.L.C., ("GOD") and Jane Doe Carter, husband and wife, and The Greatest Only Divine Productions, L.L.C. ("GODP") (collectively "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("ACT") in connection with the offer and sale of securities in the form of commodity investment contracts and/or investment contracts.

On October 15, 2008, a request for hearing was filed by the Respondents.


Accordingly, a pre-hearing conference should be scheduled.


