REQUEST FOR PROCEDURAL CONFERENCE

On October 15, 2008, the application of Arizona Water Company (the "Company") was found sufficient. As the Company notes in its application, it filed for "the total Company" citing Commission authorization to implement and utilize a group concept for filing rate applications in order to among other things simplify processing of the application and increase administrative efficiency. See Company Application at 2. The Company is divided into operating groups, Northern, Eastern and Western groups comprising 17 water systems. The last time the Company had a rate case processed on a total company basis was in 1991 culminating in Decision No. 64282.

Because of the complexity of this application and Utility Division ("Staff") resources, Staff would respectfully request a procedural conference as soon as is practical to discuss a procedural schedule.
