

RE: Docket No. W-01865A-07-0384 0385, Groom Creek Water Users Association

Mr Gleason,

1. As you are aware, the Groom Creek Water Users Association is attempting to update our water system in order to continue to provide excellent service to the Groom Creek community. The current system is old and several serious and costly breaks have occurred resulting in water outages and inconvenience to the users. The Board of Directors has been working with your organization for some 20 months to secure approval for the required rate increase and plan approval to support this update. As of this date there is still no resolution to the request as it was "tabled" again at the 15 Oct 08 meeting.

2. This continuing delay in resolution continues to handicap the Board of Directors and has begun to seriously fracture this small community of users. The \$50 rate increase was proposed by the Commission analysts (see ACC Customer Notification, July 7, 2008, Docket Number W-01865A-07-0385 ET AL) and yet was voted down in the 15 Oct 08 meeting. During this meeting a petition was presented to the Commission by Ms Berry that although addressed to the Groom Creek Board of Directors, was never presented to the Groom Creek Water Users Board of Directors. This petition was not vetted as to accuracy or appropriateness to certify that all signatories were property owners, not renters, and were, in fact, members in good standing of the Groom Creek Water Users Association.

3. Time is of the essence at present. Interest rates are down and contractors are actively seeking work. The sooner the water sytem can be updated and modernized the sooner the costly breakages and water outages stop and the community can begin to heal.

4. Request your assistance to bring this matter to resolution expeditiously.






