REQUEST FOR EXTENSION OF TIME


Applicant Del Rio Water Company (the "Company") requests that the hearing set for December 22, 2008, in this matter be vacated and that the Commission's further processing of the Company's application for a water Certificate of Convenience and Necessity be placed on hold in all respects until June 30, 2009. On or before June 30, 2009, the Company shall file notice with Docket Control notifying the Commission and Staff if it wishes to resume the processing of its application. If the Company does not file such a notice, then the Company's application shall be subject to a Staff recommendation of administrative closure. The Company has discussed this request with Staff and Staff does not oppose it.

The Procedural Order dated September 18, 2008, provides that the hearing in this matter will reconvene on December 22, 2008. It further provides that a Supplemental Staff Report must be prepared by November 17 and the Company's responses thereto must be filed by December 1. The Company requests that all of these matters be put on hold until further Procedural Order following the Company's above-described request.

1 We have been advised that the Company's sole member, The Bond Ranch at Del Rio  
2 Springs, LLC, is in the middle of a refinancing which, along with the recent turmoil in the  
3 financial markets, may influence the timing of the build-out for development of the Del Rio  
4 property. The Company therefore requests this additional time for its member to complete its  
5 refinancing and advise the Company of the appropriate phasing of the development project to be  
6 served by the Company.
