**PROCEDURAL ORDER**

12 **BY THE COMMISSION:**

13 On August 22, 2008, Arizona Water Company ("AWC" or "Company") filed with the  
14 Arizona Corporation Commission ("Commission") an application for a rate increase for all of its  
15 operating groups (Northern, Eastern, and Western), comprising 17 separate water systems.

16 On September 22, 2008, the Commission's Utilities Division ("Staff") issued an Insufficiency  
17 Letter.

18 On September 29, 2008, AWC filed a response to the Insufficiency Letter.

19 On October 15, 2008, Staff filed a letter indicating the Company's rate application was  
20 sufficient. Although the letter did not state the class of the utility pursuant to A.A.C. R14-2-103,  
21 based on the revenues set forth in the application AWC is classified and as a Class A utility.

22 On October 17, 2008, Staff filed a Request for a Procedural Conference to discuss a  
23 procedural schedule, due to the complexity of the application and Staff resources.

24 **IT IS THEREFORE ORDERED** that a **procedural conference shall be scheduled for**  
25 **November 3, 2008, at 1:30 p.m.**, at the Commission's offices, 1200 West Washington Street,  
26 Hearing Room 1, Phoenix, Arizona.
