The current base rate does include some minimum water usage, & many of us who are only part timers do not use more than the minimum. We definitely need the rate increase to do the current project & provide for orderly maintenance in the future, but the expenses should be born pro rata based upon usage. Therefore I support the increase in base rate even to 50 in one jump, but it should continue to cover a minimum amount of water usage.
