



IT IS ORDERED, pursuant to
A.R.S. § 44-1972(C) and A.A.C.
R14-4-307, that Respondents;
their agents, servants, em-
ployees, successors, assigns,
and those persons in active
concert or participation with
Respondents CEASE AND DE-
SIST from any violations of
the Securities Act.

IT IS FURTHER ORDERED that
this Temporary Order to
Cease and Desist shall remain
in effect for 180 days unless
sooner vacated, modified, or
made permanent by the Com-
mission.

IT IS FURTHER ORDERED that
this Order shall be effective
immediately.

HEARING OPPORTUNITY
RESPONDENTS may request
a hearing pursuant to A.R.S. §
44-1972 and A.A.C. R14-4-307.
If any Respondent requests a
hearing, Respondent must al-
so answer this Temporary Or-
der and Notice. A request for
hearing must be in writing
and received by the Commis-
sion within 20 business days
after service of this Notice of
Opportunity for Hearing. Each
Respondent must deliver or
mail the request to Docket
Control, Arizona Corporation

ington, Phoenix, Arizona
85007. Filing instructions may

If a request for a hearing is
timely made, the Commission
shall schedule the hearing to
begin 10 to 30 days from the
receipt of the request unless
otherwise provided by law,
stipulated by the parties, or
ordered by the Commission. If

timely made the Commission
may, without a hearing, enter
an order making this Temp-
orary Order permanent and
grant the relief requested by
the Division in this Notice of
Opportunity for Hearing.


