15 COMES NOW THE TONTO VILLAGE WATER COMPANY, by and through its attorney  
16 undersigned and submits the following response to the Letter from the Tonto Village Domestic Water  
17 Improvement District (TVDWID) dated October 13, 2008, and the letter of Jake and Kendra Garrett  
18 dated October 14, 2008.

19 It is quite apparent that both of these letters are attempting to delay or forestall the actions of the  
20 Tonto Village Water Company (hereinafter, "the Company") in its compliance with the Orders of the  
21 Arizona Corporation Commission. At the present time the Company is drilling the new well in  
22 accordance with the Commission Order. The concerns raised by both letters appear to be highly  
23 speculative and not timely filed in these proceedings.

24 The action requested in both letters is for additional monitoring of the Company's drilling  
25 activities, rather than following the normal course of action and having the Company complete the well,  
26 conduct the appropriate testing of the well and at a later date present the data concerning the well to the  
27 Commission in a subsequent rate proceeding. Until such time as the well is completed and placed  
28 online, it is premature for the Commission to expend valuable limited resources in conducting  
29 monitoring activities which are unnecessary and not called for in this instance.
