16 the Arizona Corporation Commission ("Commission") an application for a rate increase.

17 On October 21, 2008, Local Union 1116, International Brotherhood of Electrical Workers,
18 AFL-CIO ("IBEW Local 1116") filed an Application to Intervene. IBEW alleges that it represents
19 approximately 100 of Trico's employees, who have a direct and substantial interest in the proceeding.

21 IT IS THEREFORE ORDERED that IBEW Local 1116's Application to Intervene is granted.




