IN THE MATTER OF THE APPLICATION OF ASH FORK DEVELOPMENT ASSOCIATION, INC., DBA ASH FORK WATER SERVICE, FOR APPROVAL OF A RATE ADJUSTMENT.

PROCEDURAL ORDER

BY THE COMMISSION:

On October 1, 2008, Ash Fork Development Association, Inc., dba Ash Fork Water Service ("Ash Fork"), filed with the Arizona Corporation Commission ("Commission") a Rate Application for Water Companies with Annual Gross Operating Revenues (Including Requested Relief) of Less than \$250,000.

On October 31, 2008, the Commission's Utilities Division Staff ("Staff") filed a Letter of Sufficiency stating that Ash Fork's application had met the sufficiency requirements outlined in Arizona Administrative Code ("A.A.C.") R14-2-103. The letter further stated that Ash Fork has been classified as a Class C water utility, but has been granted a waiver from the requirement to file Schedules A through H and is being permitted to file a Rate Application for Water Companies with Annual Gross Operating Revenues (Including Requested Relief) of Less than \$250,000.

A procedural conference would be helpful to assist in determining the appropriate procedural schedule, whether a hearing is appropriate, and who will serve as Ash Fork's representative in the event of a hearing.

IT IS THEREFORE ORDERED that a telephonic procedural conference in this matter shall commence on November 14, 2008, at 10:00 a.m., or as soon thereafter as is practicable. To participate, each party shall call (602) 771-9951.

IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules of the Arizona Supreme Court and A.R.S. § 40-243 with respect to practice of law and admission pro hac vice.

1 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive  
2 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


