PROCEDURAL ORDER

BY THE COMMISSION:

12 On September 12, 2008, the Securities Division ("Division") of the Arizona Corporation
13 Commission ("Commission") filed a Temporary Order ("T.O.") and Notice of Opportunity for
14 Hearing ("Notice") against Helmut Weber dba Weber Capital Management ("WCM") and Vera
15 Weber, husband and wife (collectively "Respondents") in which the Division alleged multiple
16 violations of the Arizona Securities Act ("ACT") in connection with the offer and sale of securities in
17 the form of commodity investment contracts and/or investment contracts.

18 The Respondents were duly served with copies of the T.O. and Notice.

19 On October 6, 2008, a request for hearing was filed by the Respondents.

20 On October 7, 2008, by Procedural Order, a pre-hearing conference was scheduled on
21 November 5, 2008.

22 On November 5, 2008, the Division and Respondents appeared through counsel. Issues
23 concerning the case were discussed along with future scheduling matters. Counsel agreed to the
24 scheduling of a status conference and a hearing.

25 Accordingly, a status conference and a hearing should be scheduled.

26 IT IS THEREFORE ORDERED that a **status conference** shall be held on **January 21, 2009,**
27 **at 9:30 a.m.,** or as soon thereafter as practicable, at the Commission's offices, 1200 West
28 Washington Street, Hearing Room 1, Phoenix, Arizona.

1 IT IS FURTHER ORDERED that if counsel for the Respondents wishes to appear
2 telephonically at the status conference, he should, at least five days prior to the scheduled status
3 conference, contact the Commission's Hearing Division at 602-542-4250 to obtain instructions for
4 appearing telephonically.

5 IT IS FURTHER ORDERED that a **hearing** shall be held on **March 16, 2009, at 10:00 a.m.**,
6 or as soon thereafter as practicable, at the Commission's offices, 1200 West Washington Street,
7 Hearing Room 1, Phoenix, Arizona.


8 IT IS FURTHER ORDERED that the parties shall also set aside **March 17, 18, and 19, 2009**,
9 for **additional days of hearing, if necessary**.

10 IT IS FURTHER ORDERED that the Division and Respondents shall **exchange copies** of
11 their **Witness Lists and** copies of their **Exhibits** by **February 16, 2009**, with courtesy copies
12 provided to the presiding Administrative Law Judge.

13 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized
14 Communications) applies to this proceeding and shall remain in effect until the Commission's
15 Decision in this matter is final and non-appealable.

16 IT IS FURTHER ORDERED that the presiding Administrative Law Judge may rescind, alter,
17 amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by
18 ruling at hearing.


