SUMMARY OF PHILIP ENTZ
TESTIMONY

The Bureau of Indian Affairs ("BIA") previously filed prepared direct testimony of Philip Entz which will be used at the hearing beginning November 18, 2008. The following is a summary of Mr. Entz's testimony:

The Havasupai Tribe hired Mr. Entz to obtain funding for a residential development called Bar Four located on the mesa above the Grand Canyon. Mr. Entz, on behalf of the Tribe, obtained funding from the United States Department of Housing and Urban Development to construct a 13 mile extension off of the power line that is the subject of this case. Before construction, Mr. Entz asked Mohave Electric Cooperative ("Mohave") for its specifications, but Mohave refused to provide them. The Havasupai Tribe invited Mohave to attend a pre-construction conference, but Mohave did not attend. The BIA had a limited role in the construction of the extension. Because the extension runs along a BIA right of way, the BIA reviewed pole placements and had Mr. Entz complete an environmental assessment. The BIA did not fund, approve, design or construct the extension.
