**SECOND**  
**PROCEDURAL ORDER**

**BY THE COMMISSION:**

On September 30, 2008, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order ("T.O.") and Notice of Opportunity for Hearing ("Notice") against Randie Balbas and Leila Balbas, husband and wife (collectively "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("ACT") in connection with the offer and sale of securities in the form of promissory notes.

The Respondents were duly served with copies of the T.O. and Notice.

On October 16, 2008, a request for hearing was filed by the Respondents.

On October 17, 2008, by Procedural Order, a pre-hearing conference was scheduled on November 17, 2008.

On November 17, 2008, the Division and Respondents appeared through counsel. The parties are attempting to resolve the issues raised in the Notice. The Division and Respondents agreed on the scheduling of a status conference and that a hearing be scheduled in the event the issues raised in the Notice are not resolved.

Accordingly, the appropriate proceedings should be scheduled.

IT IS THEREFORE ORDERED that a **status conference** shall be held on **January 21, 2009, at 10:00 a.m.**, at the Commission's offices, 1200 West Washington Street, Hearing Room 1,



7 **Witness Lists by March 9, 2009**, with copies provided to the presiding Administrative Law Judge.
