On April 1, 2008, Staff filed a Complaint against various utilities for failure to file the 2006 Utilities Division Annual Report. On May 16, 2008, the Commission issued Decision No. 70346, a Complaint and Order to Show Cause ("Complaint" or "OSC") against the remaining Companies. On August 28, 2008, the Hearing Division conducted a pre-hearing conference. Prior to the hearing, Staff filed two supplemental updates, and at the hearing that was held on October 21, 2008, Judge Stern suggested that an additional update several weeks after the hearing may be helpful. A Recommended Order and Opinion has not yet been issued.

At the time of the hearing on October 21, 2008, Staff was still unable to confirm the current status of one of the named companies, Meadow Water Company (W-0254A), and therefore had no specific recommendation regarding that company's Certificate of Convenience and Necessity ("CC&N"). Since the hearing, Staff has determined this company's status and offers the following recommendation.

Meadow Water Company is no longer in existence and there are no more customers. The company originally had only 6 customers and those customers have either moved and the area has been vacated or the individuals have dug their own wells. Staff verified this with a site visit on November 14, 2008. Therefore, Staff now recommends that the CC&N be canceled.

Further, the following companies have filed their 2006 Annual Reports since the hearing. Staff recommends that these companies be removed from the Complaint and Order to Show Cause.
