REQUEST TO SET HEARING DATE

Pursuant to the telephonic procedural conference held Thursday, October 30, 2008, the Arizona Corporation Commission, Utilities Division ("Staff") and Sacramento Utilities, LLC ("Applicant"), agreed to a sixty (60) day extension of the time clock in this matter. Administrative Law Judge Nodes also directed the parties to cooperate to find a mutually acceptable time for hearing and make a recommendation accordingly.
