My husband John passed away this summer he and several of our friends and neighbors worked together donating our time and money to operate the system in hopes to keep the rates low and we did that very successfully for 25 years . My husband would monitor the water tank level on the tank next to our home ,if the warning siren would sound John would go see what the problem was and do what ever need to be done to resolve the problem . Sometimes he had to turn the pump on to fill the tank if the pressure was low . He would measure the level of water in the well as to not run the pump if it was too low and burn out the generator . He replaced meters ,valves , services lines, as did all of the members ,all this was volunteer we all worked together which I don't see happening any longer. This is a sad time in our community the nasty bickering and the vicious attack this present Groom Creek Water Board has done to the previous Board of good people just doing the best they could with what they had to work with.

I Live In Estates #2 we were one of the first to buy and build in the 70's when this part of the system was developed and we have had no major main line problems in this area . I live on a fixed income and if a 50.00 increase with zero usage is approved it will be a hardship to me . I will appreciate your considering we elderly with limited income when you make your decision . If we could do this replacement of the water lines gradually over a period of time , you know Rome was not built in a day.
