Federal Executive Agencies (FEA), by and through the undersigned attorney, representing all Federal customers of Arizona Public Service Company, moves to intervene in the above-captioned matter. This application is based upon the following:

1. Several Federal Executive Agencies purchase electric power from Arizona Public Service Company for a variety of federal facilities located in the territorial service area of Arizona Public Service Company. Electric power is a necessary component of providing services as required by the various federal agencies, and utility costs are paid from taxpayer monies allocated to the various federal agencies. For these reasons, Federal Executive Agencies will be directly and substantially affected by the decision in this proceeding.

2. The Department of Defense has been delegated authority by the U.S. General Services Administration pursuant to section 205 (d) of the Federal Property and Administrative Services Act of 1949, as amended (40 U.S.C. 486(d)) to represent consumer interests of the executive agencies of the Federal Government. The

1 Department of Defense has assigned responsibility for this representation to the Air Force
2 Utility Litigation & Negotiation Team for Arizona Public Service Company's service
3 area.

4 3. Granting FEA intervention will not unduly broaden the issues presented by the
5 Application in this matter, and therefore, FEA is entitled to intervention pursuant to
6 A.A.C. R14-3-105.

7 WHEREFORE, Federal Executive Agencies respectfully requests that it be granted
8 intervention in the above-referenced matter.


