MOTION TO INTERVENE

Arizona Public Service Company ("APS" or "Company"), through undersigned counsel, and pursuant to A.A.C. R14-3-105, hereby moves the Arizona Corporation Commission ("Commission") for an order allowing APS to intervene in the above-captioned proceeding. In support of its motion, APS states as follows:

1. APS is an Arizona corporation that provides electric service to customers within the State of Arizona.

2. In this Docket, Solar Alliance has applied for a declaratory order that providers of certain solar service agreements would not be public service corporations.

3. APS is affected directly and substantially by the outcome of Solar Alliance's Application because members of the Solar Alliance will have solar service agreements with APS's customers, which require interconnection with the Company's electric system. Additionally, these customers may seek incentives under the Renewable Energy Standard Rules, pursuant to R14-2-1801 *et seq.*

4. The granting of intervenor status to APS will not delay this proceeding or cause the issues to be unduly broadened, nor will it unduly prejudice Solar Alliance or any other interested parties.
