Pursuant to the request of the Chairman on November 19, 2008, Intervenor Surprise Grand Vista, JV I, LLC respectfully submits the following proposed corridor descriptions (including corridor location and width). The following descriptions have also been separately provided to the Applicant for inclusion in a draft Certificate of Environmental Compatibility incorporating the proposed corridor descriptions of all parties.

1                   **SURPRISE GRAND VISTA JV I, LLC'S PROPOSED CORRIDOR --**

2                                   **PREFERRED ROUTE, SEGMENT 3**

3           ➤ A 500-foot-wide corridor that extends east along the north right-of-way line of the Joy  
4           Ranch Road alignment for 7.0 miles from 235<sup>th</sup> Avenue (on the west) to approximately  
5           the 179<sup>th</sup> Avenue alignment (on the east); and north from said north right-of-way line for  
6           a distance of 500 feet. The proposed corridor does not encroach upon the Surprise Grand  
7           Vista master-planned community.


8                   **SURPRISE GRAND VISTA JV I, LLC'S PROPOSED CORRIDOR --**

9                                   **PREFERRED ROUTE, SEGMENT 4**

10          ➤ A 2400-foot (approximate) wide corridor that extends south along the eastern right-of-  
11          way line of the 183<sup>rd</sup> Avenue alignment for approximately 1.9 miles from the north right-  
12          of-way line of the Joy Ranch Road alignment (on the north) to the center line of the  
13          Carefree Highway alignment (on the south); and east from said 183<sup>rd</sup> Avenue eastern  
14          right-of-way line for a distance of 2400 feet (approximate). The corridor does not  
15          encroach upon the Surprise Grand Vista master-planned community.


