Re: Conditions

Dear Sirs:

On December 17th at 2:10 a.m. my first grandchild, Connor Austin Miller was born. After seeing his beautiful face and perfect body and knowing he and the rest of my family will spend many hours at our home I have made the following decision.

Should you in any stretch of the imagination choose to allow even the smallest addition or choose to allow this older plant to operate in any capacity other than 1% of the time as a peak plant, I request the following:

1). SRP be requested to purchase my home at 1887 E. Arabian Dr. Gilbert, Az. purchase price to be a minimum of \$225,000.00 including realtor fees and a minimum closing costs of \$3,000. (Using the realtor of my choice to sell my home.)

- a) Additional costs to include: moving costs
- b) With an addition \$10,000 to cover the term of loan with higher interest rates.
- c) An additional \$50,000 for pain and suffering, plus loss of employment during the hearings.

- 2). Purchase homes of all intervenors who choose to sell and leave the area.
- 3.) Purchase homes of all residents who live within a 3 mile radius of this facility who wish to sell in order to create a safe buffer zone.

Tear down and rebuild in an areas located outside the buffer zones.

- 4) Refer to all conditions are requested by all other intervenors.
- 5) Refer to all SRP conditions – make them binding.
- 6). Have SRP put \$50,000,000 million in an escrow account for all area homeowners wishing to sell their homes.
- 7. Have SRR put \$20,000 into an escrow account for all those who live within a 3 radius with health issues associated with this power plant.

8. SRP be open to damages for homeowners who live within a 3 mile radius of this plant.

9. SRP be responsible for damages to homes during construction of Warner Road, the plant, and any physical problems resulting from construction of any changes or expansion at this facility.

Please note: As the intervenors did not receive an official notice date for which to file their closing arguments or conditions, I respectfully request that this date be moved to January 19th for any intervenor who has not been able to submit their materials prior to that date.

I also request the right to add to these conditions until that date – January 19th,2000.
