PROCEDURAL ORDER

13 **BY THE COMMISSION:**

14 On April 2, 2001, Cathy Lopez, on behalf of the Joint Intervenors/Petitioners, submitted a
15 request for additional time to submit briefs in the above-captioned matter¹, and for additional time for
16 oral argument. The request for additional time for oral argument was taken under advisement, in
17 order to allow other parties the opportunity to respond.

18 On April 3, 2001, the Arizona Utility Investors Association responded, stating that it objected
19 to the request for additional time for oral argument.

20 On April 5, 2001, the applicant, Salt River Project, responded to the request, opposing
21 additional time for oral argument for the Joint Intervenors/Petitioners.

22 On April 9, 10 and 11, 2001, several Joint Intervenors/Petitioners responded, indicating that
23 20 minutes was insufficient time for their group to adequately make their oral arguments.

24 Accordingly, for good cause shown, the Joint Intervenors/Petitioners' request for additional
25 time to make oral argument on April 18, 2001 should be granted. As suggested by the responses, no
26 more than 3 spokespersons for the group, with a total combined time of 60 minutes, is reasonable.

28 ¹ By Procedural Order issued April 5, 2001, the request for additional time to file briefs was granted.

1 Further, additional time may be necessary for the Applicant, and any such determination will be made
2 by the Presiding Officer during the course of the oral arguments.

3 IT IS THEREFORE ORDERED that the request for additional time for oral argument is
4 granted as discussed herein.


