MOTION TO CONSOLIDATE

11 Arizona Corporation Commission Staff ("Staff") hereby moves to consolidate Docket No. E-
 12 01575A-08-0448, *In the Matter of the Application of Sulphur Springs Valley Electric Cooperative,*
 13 *Inc., an Arizona Corporation, for an Order Approving an(sic) Line Extension Agreement* ("Line
 14 Extension Application") with Docket Nos. E-01345A-08-0393 and E-01575A-08-0393, *In the Matter*
 15 *of the Joint Application of Arizona Public Service Company, an Arizona Corporation and Sulphur*
 16 *Springs Valley Electric Cooperative, Inc., an Arizona Corporation, for an Order Approving Electric*
 17 *Service Authorization Agreements* ("Electric Service Authorization Agreement"). Staff is filing
 18 separate motions in each of these dockets requesting this consolidation.

19 The issues involved in these matters are substantially related, and consolidation will not
 20 prejudice the rights of the parties. Staff believes that granting this consolidation will aid the
 21 Commission in its evaluation of both applications. Staff consulted with the company representatives
 22 in both matters, and they posed no objection to consolidation.

23 For these reasons, Staff requests consolidation of the above-referenced dockets.


