PROCEDURAL ORDER

BY THE COMMISSION:

On September 8, 2008, the Cross Creek Ranch Community Association (the "Association") filed an application with the Arizona Corporation Commission ("Commission") for Adjudication Not a Public Service Corporation.

On the same date, Cross Creek Ranch Water Company (the "Water Company") filed an application, in Docket No. W-20619A-08-0471, with the Commission for approval to transfer its water utility assets to its sole shareholder, the Association.

On September 19, 2008, the Association filed the legal description for the Cross Creek Ranch subdivision.

On the same date, the Association filed a Motion to Consolidate the above-captioned matter with the application to transfer assets ("Motion"). The Motion stated that the two matters are inextricably linked and that their consolidation would be administratively efficient and judicially economical.

On September 22, 2008, the Association filed a Notice of Errata, which provided a revised legal description.


On November 28, 2008, the Commission's Utilities Division ("Staff") filed an Insufficiency Letter in this docket.

Staff has not filed a response to the Association's Motion to Consolidate the two dockets.

1 Accordingly, Staff should file a response to the Motion.


